



Wrest Point Art Awards and Exhibition 2017

Entry to Wrest Point Art Awards and Exhibition is by invitation only, there is no entry fee and commission on sales is 25%. ***There is one single acquisitive prize of \$13,000*** and a People's Choice prize of a Special Occasion package from Wrest Point.

CONDITIONS OF ENTRY

- A single piece of work will be considered for the award and is open to two dimensional works in:
 - **Painting**
 - **Drawing**
 - **Printmaking**
 - **Photography**
 - **Mixed media**
- All artists must agree to allow their works to be reproduced in any promotional material associated with the Wrest Point Art Award.
- Although no size limit is imposed, large-scale work will only be accepted if space is available – generally overall size not to exceed 2.5 metres in width or height including multi panel work, and weight is not to exceed 15kg including frame.
- Works must have been created within the past two years.
- Works must be the signed work of the exhibiting artist.
- All work must be framed or stretched and dried on a timber frame with no warping and securely wired for hanging and in excellent presentation. Wrest Point Management reserves the right to refuse work deemed unsatisfactory or unsafe for hanging.

The Award winner will be announced at a function on Wednesday 17 May, 2017 which all entrants and one guest will be invited to attend. The Award is **acquisitive** and winning works will be retained by Wrest Point to add to the Federal Group's Tasmanian Collection.

The 2017 Wrest Point Art Award and Exhibition is coordinated by a committee representing Wrest Point. The judges will be nominated by Wrest Point Management, and their decision is final.

CONDITIONS OF SALE

Works will be for sale to the public and a commission of 25% to Wrest Point will apply.

If work is purchased, a tax invoice less 25% commission must be lodged by the artist, before payment by Wrest Point can be made.

Sales will be confirmed by telephone on Sunday 22 May, 2017 at the end of the exhibition. Please ensure your ENTRY FORM **contact details** are accurate.

INSURANCE

Whilst works are displayed at Wrest Point, all due care will be taken and the exhibition will be manned during the exhibition's opening hours. However, the ultimate risk of exhibiting work in a public place rests with the artist.

DELIVERY/COLLECTION OF WORK

- Work delivered must be **CLEARLY LABELED** on the reverse with the **artist name, title and sell price**.
- Delivery of works is to the Boardwalk Gallery on **Wednesday 17 May, 2017 between 8.30 am and midday**.
- Arrangements must be made for unsold work to be **collected** from the Boardwalk Gallery between **5-6pm on Sunday 21 May** and **8.30 am-noon on Monday 22 May**. No responsibility will be taken for any works not collected within this time.
- The Exhibition will be open to the public for 4 days from **10am to 6pm** on Thursday 18 May, Friday 19 May, Saturday 20 May and Sunday 21 May, 2017 from **10am to 5pm**.
- Any packaging used to deliver the item must be taken away as no storage will be available on site for the duration of the exhibition.

CHECKLIST

1. Complete and return the enclosed **GST form**.
2. Include recent **curriculum vitae**, a maximum two A4 pages, which will be available for public viewing at the exhibition.
3. Complete and return an **artist statement** relating to the work submitted, maximum one A4 page.
4. Read and understand the enclosed Conditions of Entry and **sign and return the Entry Form**.
5. Keep a copy of entry form for records.

GENERAL

GST is different for hobbyists and those with an ABN who are registered for GST. The GST is only collected on art works that are sold. Wrest Point charges 25% commission on works sold.

GST REGISTERED ARTISTS

Your price should include the 10% GST. Please fill out the details here, this will be attached to your information and is effectively your GST invoice.
